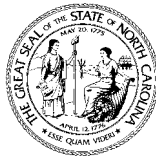

7 NATIONALLY CERTIFIED SCHOOL PSYCHOLOGIST CREDENTIAL.";

10 and on page 31, lines 9-10, by inserting the following between those lines:

12 **"PART VII-C. SCHOOLS PSYCHOLOGIST LICENSES**

14 **SECTION 7.7.(a)** G.S. 115C-270.20(b) is repealed.

15 **SECTION 7.7.(b)** The catch line of G.S. 115C-270.20 reads as rewritten:

16 **"§ 115C-270.20. ~~Licensure~~ Teacher licensure requirements."**

17 **SECTION 7.7.(c)** Article 17E of Chapter 115C of the General Statutes is amended
18 by adding a new section to read:

19 **"§ 115C-270.21. Administrator and student services personnel licensure requirements.**

20 (a) Administrators. – The State Board shall establish classification and levels of
21 preparation necessary for issuance of licenses for administrators, as provided in this Chapter.

22 (b) Student Services Personnel. – The State Board shall establish classification and levels
23 of preparation necessary for issuance of licenses for student services personnel, as provided in
24 this Article.

25 The State Board of Education shall issue a school psychologist license to an individual who
26 does any of the following: (i) meets the criteria for licensure as a school psychologist established
27 by the State Board or (ii) holds the Nationally Certified School Psychologist credential issued by
28 the National Association of School Psychologists. For any individual that holds the Nationally
29 Certified School Psychologist credential, a school psychologist license shall be issued to the
30 individual within 60 days of submission of a completed application that includes documentation
31 verifying that credential."
