AN ACT TO MAKE VARIOUS CHANGES AND TECHNICAL CORRECTIONS TO THE
LAWS GOVERNING THE ADMINISTRATION OF JUSTICE.

The General Assembly of North Carolina enacts:

**PART I. PROPOSED STATUTORY CHANGES AS RECOMMENDED BY THE
ADMINISTRATIVE OFFICE OF THE COURTS**

INCREASED FLEXIBILITY OF EMERGENCY JUDGE ASSIGNMENTS

SECTION 1. G.S. 7A-52(a) reads as rewritten:

"(a) Judges of the district court and judges of the superior court who have not reached the mandatory retirement age specified in G.S. 7A-4.20, but who have retired under the provisions of G.S. 7A-51, or under the Uniform Judicial Retirement Act after having completed five years of creditable service, may apply as provided in G.S. 7A-53 to become emergency judges of the court from which they retired. From the commissioned emergency district, superior, and special superior court judges, the Chief Justice of the Supreme Court shall create two lists of active emergency judges and two lists of inactive emergency judges. For emergency superior and special superior court judges, the active list shall be limited to a combined total of 10 emergency judges; all other emergency superior and special superior court judges shall be on an inactive list. For emergency district court judges, the active list shall be limited to 25 emergency judges; all other emergency district court judges shall be on an inactive list. There is no limit to the number of emergency judges on either inactive list. In the Chief Justice's discretion, emergency judges may be added or removed from their respective active and inactive lists, as long as the respective numerical limits on the active lists are observed. The Chief Justice is requested to consider geographical distribution in assigning emergency judges to an active list but may utilize any factor in determining which emergency judges are assigned to an active list. The Chief Justice of the Supreme Court may order any emergency district, superior, or special superior court judge on an active list who, in his opinion, is competent to perform the duties of a judge, to hold regular or special sessions of the court from which the judge retired, as needed. Order of assignment shall be in writing and entered upon the minutes of the court to which such emergency judge is assigned. An emergency judge shall only be assigned in the event of a:

- (1) Death of a sitting judge.
- (2) ~~Disability~~ Medical leave absence of a sitting judge.
- (3) Recall to active military duty of a sitting judge.
- (4) Retirement or removal of a sitting judge.
- (5) Court case-management emergency.

5 **ELIMINATE COURT COST WAIVER NOTICE AND REPORT**

6 **SECTION 2.** G.S. 7A-304 reads as rewritten:

7 **"§ 7A-304. Costs in criminal actions.**

8 (a) In every criminal case in the superior or district court, wherein the defendant is
 9 convicted, or enters a plea of guilty or nolo contendere, or when costs are assessed against the
 10 prosecuting witness, the following costs shall be assessed and collected. No costs may be
 11 assessed when a case is dismissed. Only upon entry of a written order, supported by findings of
 12 fact and conclusions of law, determining that there is just cause, the court may (i) waive costs
 13 assessed under this section or (ii) waive or reduce costs assessed under subdivision (7), (8), (8a),
 14 (11), (12), or (13) of this section. ~~No court may waive or remit all or part of any court fines or~~
 15 ~~costs without providing notice and opportunity to be heard by all government entities directly~~
 16 ~~affected. The court shall provide notice to the government entities directly affected of (i) the date~~
 17 ~~and time of the hearing and (ii) the right to be heard and make an objection to the remission or~~
 18 ~~waiver of all or part of the order of court costs at least 15 days prior to hearing. Notice shall be~~
 19 ~~made to the government entities affected by first class mail to the address provided for receipt of~~
 20 ~~court costs paid pursuant to the order.~~

22 (a2) ~~The Administrative Office of the Courts shall report on October 1, 2018, and annually~~
 23 ~~thereafter, to the Joint Legislative Oversight Committee on Justice and Public Safety on the~~
 24 ~~implementation of the notice of waiver of costs to the government entities directly affected as~~
 25 ~~required by subsection (a) of this section.~~

28 **REDUCE NORTH CAROLINA ADMINISTRATIVE OFFICE OF THE COURTS**

29 **REPORTS TO THE GENERAL ASSEMBLY**

30 **SECTION 3.(a)** G.S. 7A-343 reads as rewritten:

31 **"§ 7A-343. Duties of Director.**

32 The Director is the Administrative Officer of the Courts, and the Director's duties include all
 33 of the following:

34 ...

35 (8a) Prepare and submit ~~a semiannual~~ an annual report on the activities of each
 36 North Carolina business court site to the Chief Justice, the chairs of the House
 37 of Representatives Appropriations Committee on Justice and Public Safety and the Senate Appropriations Committee on Justice and Public Safety, the
 38 chairs of the of the Joint Legislative Oversight Committee on Justice and
 39 Public Safety, and all other members of the General Assembly on February 1
 40 ~~and August 1, 1.~~ The report shall include the following information for each
 41 business court site:

- 42 a. The number of new, closed, and pending cases for the previous three
- 43 years.
- 44 b. The average age of pending cases.
- 45 c. The number of motions pending over six months after being filed.
- 46 d. The number of cases in which bench trials have been concluded for
- 47 over six months without entry of judgment, including any
- 48 accompanying explanation provided by the Business Court.

49 The ~~August 1~~ report shall include an accounting of all business court activities
 50 for the previous fiscal year, including the itemized annual expenditures.

SECTION 3.(b) G.S. 7A-346.2 reads as rewritten:

"§ 7A-346.2. Various reports to General Assembly.

...

(b) ~~The Administrative Office of the Courts shall report by April 1 of each odd-numbered year to the Chairs of the Senate and House Appropriations Committees and the Chairs of the Senate and House Appropriations Subcommittees on Justice and Public Safety on the economic viability of the worthless check collection programs established by district attorneys pursuant to G.S. 14-107.2, including an assessment of whether any adjustments need to be made to ensure that the programs, on a statewide basis, are self-supporting.~~

(c) ~~The Administrative Office of the Courts, in consultation with the Conference of Clerks of Superior Court, shall make any necessary modifications to its information systems to maintain records of all cases in which the defendant in a criminal case withdraws an appeal for trial de novo in superior court and the superior court judge has signed an order remanding the case to the district court and shall report on those remanded cases to the chairs of the Senate Appropriations Committee on Justice and Public Safety, the chairs of the House Appropriations Committee on Justice and Public Safety, and the chairs of the Joint Legislative Oversight Committee on Justice and Public Safety by February 1 of each year. The report shall (i) include the total number of remanded cases and also the total number of those cases for which the court has remitted costs and (ii) aggregate those totals by the district in which they were granted and by the name of each judge ordering remand.~~ court. The Administrative Office of the Courts may obtain any information that may be needed from individual clerks of superior court in order to make the modifications necessary to maintain the records required under this section."

SECTION 3.(c) G.S. 7A-346.3 is repealed.

SECTION 3.(d) G.S. 7A-350 reads as rewritten:

"§ 7A-350. Annual report on Records of criminal court cost waivers.

~~The Administrative Office of the Courts shall maintain records of all cases in which a judge makes a finding of just cause to grant a waiver of criminal court costs under G.S. 7A-304(a) and shall report on those waivers to the chairs of the House of Representatives and Senate Appropriations Committees on Justice and Public Safety and the chairs of the Joint Legislative Oversight Committee on Justice and Public Safety by February 1 of each year. The report shall aggregate the waivers by the district in which the waiver or waivers were granted and by the name of each judge granting a waiver or waivers.~~ G.S. 7A-304(a)."

CONFORM PETITION FOR SPOUSAL ALLOWANCE TO REFLECT CURRENT SPOUSAL YEARLY ALLOWANCE MAXIMUM

SECTION 4. G.S. 30-29 reads as rewritten:

"§ 30-29. What petition must show.

In the petition the petitioner shall set forth, besides the facts entitling petitioner to a year's support and the value of the support claimed, the further facts that the personal estate of which the decedent died possessed exceeded ~~thirty thousand dollars (\$30,000), sixty thousand dollars (\$60,000)~~ and also whether or not an allowance has been made to petitioner and the nature and value thereof."

CLARIFY DAYS WHEN FORECLOSURE SALES ARE PERMITTED

SECTION 5.(a) G.S. 45-21.21(f) is repealed.

SECTION 5.(b) G.S. 45-21.23 reads as rewritten:

"§ 45-21.23. Time of sale.

A sale shall begin at the time designated in the notice of sale or as soon thereafter as practicable, but not later than one hour after the time fixed therefor unless it is delayed by other sales held at the same place. The sale shall be held between the hours of 10:00 A.M. and 4:00

1 P.M. on any day ~~other than Sunday or a legal holiday when the courthouse is closed for~~
2 ~~transactions when the clerk's office is normally open for transactions.~~"

4 **DOCKETING OF STATE BAR ORDERS AND FINAL DETERMINATIONS**

5 **SECTION 6.** G.S. 84-32(a) reads as rewritten:

6 "(a) In cases heard by the disciplinary hearing commission or any committee thereof, the
7 proceedings shall be recorded by a certified court reporter and an official copy of all exhibits
8 introduced into evidence shall be made and preserved in the office of the secretary-treasurer.
9 Final judgments of censure, whether issued by the State Bar Grievance Committee or the
10 disciplinary hearing commission, and final orders of suspension or disbarment issued by the
11 disciplinary hearing commission shall be entered upon the judgment docket of the superior court
12 in the district wherein the respondent resides or practices law, and also upon the minutes of the
13 Supreme Court of North Carolina; and the judgment shall be effective throughout the State. Final
14 determinations of incapacity or disability, whether issued by the State Bar Grievance Committee

19 **ESTABLISH FEE FOR FAILURE TO ATTEND A HEARING AS RECOMMENDED BY** 20 **THE DISPUTE RESOLUTION COMMISSION**

21 **SECTION 7.(a)** G.S. 7A-38.2(f) reads as rewritten:

22 "(f) In connection with any investigation or hearing conducted pursuant to an application
23 for certification or qualification of any mediator, other neutral, or training program, or conducted
24 pursuant to any disciplinary matter, the chair of the Dispute Resolution Commission or ~~his/her~~
25 the chair's designee, may:may do any of the following:

- 26 (1) Administer oaths and ~~affirmations;~~affirmations.
- 27 (2) Sign and issue subpoenas in the name of the Dispute Resolution Commission
28 or direct its executive secretary to issue such subpoenas on its behalf requiring
29 attendance and the giving of testimony by witnesses and the production of
30 books, papers, and other documentary ~~evidence;~~evidence.
- 31 (3) Apply to the General Court of Justice, Superior Court Division, for any order
32 necessary to enforce the powers conferred in this section, including an order
33 for injunctive relief pursuant to G.S. 1A-1, Rule 65, when a certified
34 mediator's conduct necessitates prompt action.
- 35 (4) Assess and collect an administrative fee from any person who appeals an
36 adverse determination to the full Commission for a hearing and fails to attend
37 the hearing without good cause as determined by the chair of the Commission.
38 The fee assessed shall be the lesser of the Commission's actual expenses for
39 the hearing or two thousand five hundred dollars (\$2,500). The fees collected
40 shall be deposited in the Dispute Resolution Fund established pursuant to
41 subsection (d) of this section."

42 **SECTION 7.(b)** This section becomes effective July 1, 2019, and applies to hearings
43 held on or after that date.

45 **NOTIFICATION OF FAILURE TO APPEAR FOR FINGERPRINTING**

46 **SECTION 8.** G.S. 15A-502(f) reads as rewritten:

47 "(f) If a person is charged with an offense for which fingerprints are required pursuant to
48 this section but the person is not arrested for that offense, the court before which the charge is
49 pending shall order the defendant to submit to fingerprinting by the Sheriff or other appropriate
50 law enforcement agency at the earliest practical opportunity. If the person fails to appear for
51 fingerprinting as ordered by the court, the ~~sheriff~~-Sheriff or other designated agency shall so

1 inform the court, and the court may initiate proceedings for criminal contempt against the person
2 pursuant to G.S. 5A-15, including issue of an order for arrest pursuant to G.S. 5A-16, if
3 necessary. The defendant shall continue to be subject to the court's order to provide fingerprints
4 until submitted."
5

6 **POST-APPEAL JUDGMENT ENFORCEMENT**

7 **SECTION 9.(a)** G.S. 15A-1452 reads as rewritten:

8 "**§ 15A-1452. Execution of sentence upon determination of appeal; compliance with**
9 **directive of appellate court.**

10 (a) If an appeal is ~~withdrawn~~, withdrawn for a judgment that imposed an active sentence
11 or imposed only monetary obligations without probation, the clerk of superior court must enter
12 an order reflecting that fact and directing compliance with the judgment.

13 (a1) If an appeal is withdrawn for a judgment that imposed a suspended sentence, the clerk
14 of superior court shall notify the district attorney, who shall calendar a review hearing as required
15 in subsection (d) of this section.

16 (b) If the appellate division affirms ~~the judgment~~ in whole or in part, ~~part~~ a judgment that
17 imposed an active sentence or imposed only monetary obligations without probation, the clerk
18 of superior court must file the directive of the appellate division and order compliance with its
19 terms.

20 (b1) If the appellate division affirms a judgment that imposed a suspended sentence, the
21 clerk of superior court shall file the directive of the appellate division and bring the matter to the
22 attention of the district attorney, who shall calendar a review hearing as provided in subsection
23 (d) of this section.

24 (c) If the appellate division orders a new trial or directs other relief or proceedings, the
25 clerk must file the directive of the appellate court and bring the directive to the attention of the
26 district attorney or the court for compliance with the directive.

27 (d) When notified by the clerk as provided in this section, the district attorney shall
28 calendar a hearing in superior court for review of the judgment imposed. The defendant shall be
29 entitled to be present and represented by counsel to the same extent as in the original sentencing
30 hearing.

31 (1) At the review hearing, the court shall enter an order directing compliance with
32 the judgment either as imposed or as modified as provided in this subsection.
33 The defendant's period of probation shall commence as of the date of the
34 court's order.

35 (2) If the defendant's ability to comply with any date or period of time specified
36 in the original judgment has become impractical or impossible due to the
37 pendency of the appeal, the court may modify those dates in order to give
38 effect to the original judgment as closely as possible.

39 (3) The court shall not modify the judgment other than to adjust dates or periods
40 for compliance as provided in subdivision (2) of this subsection, unless the
41 court otherwise complies with the procedures for modification of probation in
42 G.S. 15A-1344."

43 **SECTION 9.(b)** This section becomes effective December 1, 2019, and applies to
44 any mandate of the appellate division received in the trial division on or after that date.

46 **ALIGN NOTIFICATION PERIOD FOR FAILURE TO PAY WITH CURRENT** 47 **STATUTORY COMPLIANCE PERIOD**

48 **SECTION 10.** G.S. 20-217(g2) reads as rewritten:

49 "(g2) Pursuant to G.S. 20-54, failure of a person to pay any fine or costs imposed pursuant
50 to this section shall result in the Division withholding the registration renewal of a motor vehicle
51 registered in that person's name. The clerk of superior court in the county in which the case was

1 disposed shall notify the Division of any person who fails to pay a fine or costs imposed pursuant
2 to this section within ~~20-40~~ days of the date specified in the court's judgment, as required by
3 G.S. 20-24.2(a)(2). The Division shall continue to withhold the registration renewal of a motor
4 vehicle until the clerk of superior court notifies the Division that the person has satisfied the
5 conditions of G.S. 20-24.1(b) applicable to the person's case. The provisions of this subsection
6 shall be in addition to any other actions the Division may take to enforce the payment of any fine
7 imposed pursuant to this section."

13 otherwise deliver notice of the adoption proceeding to any agency that has undertaken but not
14 yet completed a preplacement assessment and any agency ordered to make a report to the court

25 persons, in the administration of trusts under wills and under powers of attorney, in trust
26 proceedings under G.S. 36C-2-203, in estate proceedings under G.S. 28A-2-4, in power of
27 attorney proceedings under G.S. 32C-1-116(a), and in collections of personal property by
28 affidavit, the following costs shall be assessed:

30 (2b) Notwithstanding subdivisions (1) and (2) of this subsection, ~~no costs shall be~~
31 ~~the only cost~~ assessed when the estate is administered or settled pursuant to
32 ~~G.S. 28A-25-6.~~ G.S. 28A-25-6 shall be a fee of twenty dollars (\$20.00) to be
33 assessed upon filing of the application.

49 petitions filed on or after that date.

3 **SECTION 13.** G.S. 7A-809 is repealed.

5 **IN REM FORECLOSURE EXECUTION PROCEDURE AND FEES**

6 **SECTION 14.(a)** G.S. 7A-308(a) reads as rewritten:

7 "(a) The following miscellaneous fees and commissions shall be collected by the clerk of
8 superior court and remitted to the State for the support of the General Court of Justice:

9 (1) Foreclosure under power of sale in deed of trust or mortgage.....\$300.00

10 If the property is sold under the power of sale, an additional amount
11 will be charged, determined by the following formula: forty-five
12 cents (.45) per one hundred dollars (\$100.00), or major fraction
13 thereof, of the final sale price. If the amount determined by the
14 formula is less than ten dollars (\$10.00), a minimum ten dollar
15 (\$10.00) fee will be collected. If the amount determined by the
16 formula is more than five hundred dollars (\$500.00), a maximum
17 five hundred-dollar (\$500.00) fee will be collected.

18 (1a) In rem foreclosures conducted under G.S. 105-375, if the property is sold
19 under execution.....\$300.00

22 **SECTION 14.(b)** G.S. 105-375 reads as rewritten:

23 **"§ 105-375. In rem method of foreclosure.**

24 ...

25 (b) Docketing Certificate of Taxes as Judgment. – In lieu of following the procedure set
26 forth in G.S. 105-374, the governing body of any taxing unit may direct the tax collector to file
27 with the clerk of superior court, no earlier than 30 days after the tax liens were advertised, a
28 certificate showing the following: the name of the taxpayer as defined in G.S. 105-273(17), for
29 each parcel on which the taxing unit has a lien for unpaid taxes, together with the amount of
30 taxes, penalties, interest, and costs that are a lien thereon; the year or years for which the taxes
31 are due; and a description of the property sufficient to permit its identification by parol testimony.
32 The fees for docketing and indexing the certificate assessed pursuant to G.S. 7A-308(a)(11) shall
33 be payable to the clerk of superior court at the time the taxes are collected or the property is sold.
34 ...

35 (i) Issuance of Execution. – At any time after three months and before two years from
36 the indexing of the judgment as provided in subsection (b), above, execution shall be issued at
37 the request of the tax collector in the same manner as executions are issued upon other judgments
38 of the superior court, and the real property shall be sold by the sheriff in the same manner as
39 other real property is sold under execution with the following exceptions:

40 (1) No debtor's exemption shall be allowed.

41 (2) In lieu of personal service of notice on the taxpayer, the sheriff shall send
42 notice by registered or certified mail, return receipt requested, to the taxpayer
43 at the taxpayer's last known address at least 30 days prior to the day fixed for
44 the sale. If within 10 days following the mailing of the notice, a return receipt
45 has not been received by the sheriff indicating receipt of the notice, then the
46 sheriff shall make additional efforts to locate and notify the taxpayer and all
47 lienholders of record of the sale under execution in accordance with
48 subdivision (4) of subsection (c) of this section.

49 (3) The sheriff shall add to the amount of the judgment as costs of the sale any
50 postage expenses incurred by the tax collector and the sheriff in foreclosing
51 under this section.

- 1 (4) In any advertisement or posted notice of sale under execution, the sheriff may
 2 (and at the request of the governing body shall) combine the advertisements
 3 or notices for properties to be sold under executions against the properties of
 4 different taxpayers in favor of the same taxing unit or group of units; however,
 5 the property included in each judgment shall be separately described and the
 6 name of the taxpayer specified in connection with each.

7 The purchaser at the execution sale shall acquire title to the property in fee simple free and
 8 clear of all claims, rights, interests, and liens except the liens of other taxes or special assessments
 9 not paid from the purchase price and not included in the judgment.

10 (i1) Fee. – The fee assessed in G.S. 7A-308(a)(1a) shall be payable to the clerk of superior
 11 court out of the sale proceeds at the time the property is sold.

13 **SECTION 14.(c)** This section becomes effective October 1, 2019, and applies to
 14 execution sales conducted on or after that date.

15 **AUTHORIZE RETIRED CLERK TO ADMINISTER OATHS**

16 **SECTION 15.** G.S. 11-7.1(a) reads as rewritten:

17 "(a) Except as otherwise specifically required by statute, an oath of office may be
 18 administered ~~by~~by any of the following:

- 19 (1) A justice, judge, magistrate, clerk, assistant clerk, or deputy clerk of the
 20 General Court of Justice, a retired ~~justice or judge~~justice, judge, or clerk
 21 of the General Court of Justice, or any member of the federal judiciary;~~judiciary.~~
 22 (2) The Secretary of ~~State;~~State.
 23 (3) A notary ~~public;~~public.
 24 (4) A register of ~~deeds;~~deeds.
 25 (5) A mayor of any city, town, or incorporated ~~village;~~village.

31 **SECTION 16.** G.S. 28A-25-6(f) reads as rewritten:

32 "(f) If no administrator has been appointed, the clerk of superior court ~~shall~~shall, upon
 33 motion of the clerk or upon the application of an interested party, disburse the money received
 34 under this section for the following purposes and in the following order:

- 35 (1) To pay the surviving spouse's year's allowance and children's year's allowance
 36 assigned in accordance with ~~law;~~law.
 37 (2), (3) Repealed by Session Laws 1981, c. 383, s. 3.
 38 (4) All other claims shall be disbursed according to the order set out in
 39 G.S. 28A-19-6.

40 Notwithstanding the foregoing provisions of this subsection, the clerk shall pay, out of funds
 41 provided the deceased pursuant to G.S. 111-18 and Part 3 of Article 2 of Chapter 108A of the
 42 General Statutes of North Carolina, any lawful claims for care provided by an adult care home
