1 moves to amend the bill on page 3, line 16, by increasing the requirements by \$1,100,000 for the
2 2019-2020 fiscal year and by \$2,100,000 for the 2020-2021 fiscal year; and

4 on page 3, line 31, by reducing the requirements by \$1,100,000 for the 2019-2020 fiscal year and
5 by \$2,100,000 for the 2020-2021 fiscal year; and

7 on page 100, lines 23-24, by inserting between those lines the following new section to read:

9 **"FUNDS/COLLEGE OF HEALTH SCIENCES AT UNC PEMBROKE**

10 **SECTION 8.11.(a)** Notwithstanding any other provision of law, the funds
11 appropriated by this act for the 2019-2021 fiscal biennium to the Board of Governors for the
12 University of North Carolina at Pembroke (UNC-Pembroke) in Fund Code 16082 shall be
13 increased by (i) one million one hundred thousand dollars (\$1,100,000) in recurring funds for the
14 2019-2020 fiscal year and (ii) by an additional one million dollars (\$1,000,000) in recurring funds
15 for the 2020-2021 fiscal year to support program development and operating budgets for
16 expanded and additional programs for the College of Health Sciences at UNC-Pembroke. The
17 funds shall be used for necessary faculty, staff, and equipment for the programs.

18 **SECTION 8.11.(b)** Notwithstanding any other provision of law, the funds
19 appropriated by this act for the 2019-2021 fiscal biennium to the Board of Governors for data
20 analytics in Fund Code 16011 shall be decreased by (i) one million one hundred thousand dollars
21 (\$1,100,000) in recurring funds for the 2019-2020 fiscal year and (ii) by an additional one million
22 dollars (\$1,000,000) in recurring funds for the 2020-2021 fiscal year."; and

24 by adjusting the appropriate totals accordingly.
