1 moves to amend the bill on page 269, lines 25-30, by deleting those lines and substituting the
2 following new language:

3 "(1) A grant in the amount of ten million eight hundred fifty thousand dollars
4 (\$10,850,000) for the 2019-2020 fiscal year and a grant in the amount of two
5 million seven hundred fifty thousand dollars (\$2,750,000) for the 2020-2021
6 fiscal year to the North Carolina Civil War & Reconstruction History Center
7 Foundation, a nonprofit corporation, for construction of the North Carolina
8 Civil War & Reconstruction History Center.";

10 and on page 269, lines 37-38, by inserting between those lines the following new language:

11 "(4) A grant in the amount of one million two hundred fifty thousand dollars
12 (\$1,250,000) for the 2019-2020 fiscal year and a grant in the amount of two
13 hundred fifty thousand dollars (\$250,000) for the 2020-2021 fiscal year to the
14 Fayetteville\Cumberland County Dr. Martin Luther King Jr. Committee, a
15 nonprofit organization, to complete the development of the Martin Luther
16 King, Jr. Park.";

18 and on page 270, lines 28-29, by inserting the following new subsection to read:

19 "**SECTION 39.2.(i)** Notwithstanding the Committee Report referenced in Section
20 42.2 of this act or any other provision of law to the contrary, the funds allocated to the Civil War
21 History Center are reduced by one million two hundred fifty thousand dollars (\$1,250,000),
22 nonrecurring, in the 2019-2020 fiscal year, and are reduced by two hundred fifty thousand dollars
23 (\$250,000), nonrecurring, in the 2020-2021 fiscal year. The funds allocated to the
24 Fayetteville\Cumberland County Dr. Martin Luther King Jr. Committee are increased by one
25 million two hundred fifty thousand dollars (\$1,250,000), nonrecurring, in the 2019-2020 fiscal
26 year, and are increased by two hundred fifty thousand dollars (\$250,000), nonrecurring, in the
27 2020-2021 fiscal year.";

29 and by adjusting the appropriate totals accordingly.
