1 moves to amend the bill on page 228 by inserting the following between lines 50 and 51:

2 **"TO RESTORE COURT POSITIONS**

3 **SECTION 15.10A.(a)** Notwithstanding the Committee Report described in Section  
4 42.2 of this act, the net appropriation for Budget Code 12000, Fund Code 1200 (Appellate  
5 Courts), is increased by two hundred sixty-six thousand nine hundred fifty-three dollars  
6 (\$266,953) in recurring funds in both years of the 2019-2021 fiscal biennium.

7 **SECTION 15.10A.(b)** Notwithstanding the Committee Report described in Section  
8 42.2 of this act, the net appropriation for Budget Code 12000, Fund Code 1700 (Judicial  
9 Standards Commission), is increased by one hundred thirty-eight thousand one hundred ninety-  
10 six dollars (\$138,196) in recurring funds in both years of the 2019-2021 fiscal biennium.

11 **SECTION 15.10A.(c)** The Administrative Office of the Courts shall retain position  
12 numbers 60002211 (Judicial Standards Executive Director), 65024918 (Supreme Court  
13 Administrative Council), 60005341 (Research Assistant II), and 65025745 (Supreme Court Staff  
14 Attorney).

15 **SECTION 15.10A.(d)** Notwithstanding the Committee Report described in Section  
16 42.2 of this act, the net appropriation for Budget Code 12000, Fund Code 1600 (Special Assistant  
17 United States Attorney), is decreased by three hundred ninety-nine thousand two hundred  
18 seventy-nine dollars (\$399,279) in funds in FY 2019-2020 and by four hundred five thousand  
19 one hundred forty-nine dollars (\$405,149) in funds in FY 2020-2021, and the FTE is decreased  
20 by three in both years of the 2019-2021 fiscal biennium.

21 **SECTION 15.10A.(e)** Notwithstanding the Committee Report described in Section  
22 42.2 of this act, the net appropriation for Budget Code 12000, Fund Code 1700 (Human  
23 Trafficking Commission), is decreased by five thousand eight hundred seventy dollars (\$5,870)  
24 in funds in FY 2019-2020.";
