

HOUSE BILL 362: presented in committee. 15-Point Scale For School Performance Grades.

OVERVIEW: House Bill 362 would permanently change the scale for the determination of school performance grades to a 15 point scale, require the State Board of Education to adopt emergency rules in preparation for permanent rulemaking; and direct the State Board of Education to study the reporting methods used for school accountability purposes on the North Carolina annual school report cards

CURRENT LAW: The State Board of Education (SBE) is required to award school achievement, growth, and performance scores and an associated A-F performance grade for public schools. School performance scores are calculated by adding the school achievement score as 80% of the total score and the school growth score as 20% of the total score and then converting the total score to a 100-point scale. A-F school performance grades are assigned a corresponding letter grade based on a ten-point grading scale, as follows:

S.L. 2014-5 changed the scale for calculating A-F school performance grades from a ten-point scale to a 15-point scale for the 2013-2014 school year only, as follows:

Less than 40	F			

S.L. 2015-17 extended the use of the 15-point scale for assignment of A-F school performance grades for the 2014-2015 and 2015-2016 school years. Section 8.19 of S.L. 2016-94 further extended the use of the 15-point scale for assignment of A-F school performance grades for the 2016-2017, 2017-2018, and 2018-2019 school years.

BILL ANALYSIS: House Bill would make the following changes in Parts I and III:

- Permanently change the scale to a 15-point scale for assignment of A-F school performance grades.
- Require the State Board of Education, in consultation with the State Superintendent of Public Instruction, to study (i) the weighting of the school achievement score and the school growth score in calculation of the

overall school performance score to best reflect performance and progress for each school and (ii) the reporting methods used to meaningfully differentiate schools on the North Carolina annual school report cards. The State Board would report on recommendations to the Joint Legislative Education Oversight Committee by February 15, 2020.

Part II of the bill would also revive interim rules for the State Board of Education until August 9, 2019, require the State Board to adopt those rules as emergency rules by that date, and require adoption of the emergency rules as permanent rules by May 30, 2020.

EFFECTIVE DATE: The bill would become effective when it becomes law and Section 1 of the bill would apply beginning with the 2019-2020 school year.
